Important Guidelines for the admission of LL.M. (2 Years Course)-

- ❖ **Admission Criteria:** Admission for the LL.M. (2 Years Course) A.Y. 2022-23 will be completely on the basis of merit of LL.M. Common Entrance Test (CET) Examination and **after the scrutiny of all required documents (offline mode) by the Admission Committee of the College. Timings – 10:00 AM to 04:00 PM (Excluding lunch break i.e. 01:00 pm – 01:30 pm).**
- ❖ **Reservation Policy:** The College has 51% seats reserved for the **Hindi Linguistic Minority**. Those students who wish to apply under this category will be required to submit any document mentioned herewith - Birth Certificate or School Leaving Certificate or a notarized Affidavit stating that candidates **Mother Tongue is 'Hindi'**.
- ❖ **Mode of Admission:** The Online admission link will be provided by the college for filling the online admission form. The fees for the academic year will be accepted online **ONLY** after the final verification of all required documents.
- ❖ **Cancellation Policy-** In case of cancellation of admission, the student will be required to submit an application through mail on the college email address (studllm@hvpslawcollege.edu.in) before 22nd of October 2022 (Saturday). The candidates who cancel their admission. Through the above-mentioned process will get a refund of fees paid only by cheque within **thirty working days after deducting Rs.1000 as admission processing charges**. The cheque will be in the name of Student/Parent. The cheque needs to be collected physically during the college working hours i.e. 10:00 AM to 4:00 PM. (Excluding lunch break i.e. 01:00 pm – 01:30 pm) Post cancellation, requests for reconsideration of admission shall not be entertained in any case.
