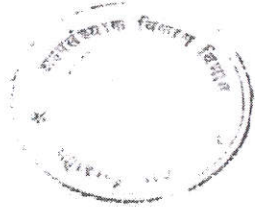

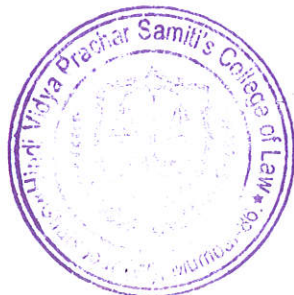

- Seats of the Unaided (Vina-Anudanit) Courses will be distributed as above till they become eligible for Government aid.

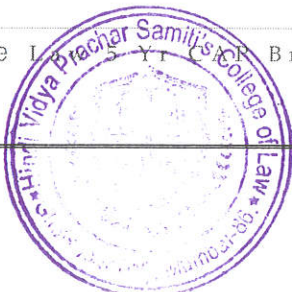
CAP Seats = Sanctioned Intake - Institutional Quota
