## Policy for Placement and Internship opportunities

Following are the policies that the institution has for placement and internship opportunities:

### 1. Internships

- The institution coordinates with advocates and law firms wherein they notify whenever there is any vacancy.
- Once the institution becomes aware of the same, it puts up a notice and informs all the students regarding the opportunity. The notice has the contact details of the advocates and law firms so that the students can directly contact the respective advocates and firms without any hassle. ## 2. Placements
